#### **HCBS Waiver Program Goals**



- Protect people's health and welfare
- Provide adequate and reasonable provider standards to meet the needs of the target population
- Deliver services through an individualized and person-centered plan of care
- Demonstrate that providing waiver services won't cost more than providing these services in an institution

  - Current Enrollment:2,000

- MSSP
  - Statewide coverage
  - Waitlists managed by Sites
  - Current Enrollment: 11,000
- SF-CLSB
  - City and County of SF
  - No Waitlist
  - Current Enrollment: 17

#### **Purpose of the HCBS Waivers**



- Provide Medi-Cal beneficiaries and their families with choices
- Remain cost-neutral to care received in a facility
- Authorize services that support the beneficiary's medical care needs and are provided in a safe environment

## **Background of DHCS Administered Waivers**



#### NF/AH and IHO:

- January 2007- consolidated the Nursing Facility A/B (NF A/B) Waiver, Nursing Facility Subacute (NF S/A) Waiver, and In-Home Medical Care (IHMC) Waiver into one waiver
- Offers the same services and includes community and habilitation services
- Expanded waiver capacity
- Included Habilitation and SNF Transition services
- 2<sup>nd</sup> renewal cycle

## **Background of DHCS Administered Waivers**



#### ALW:

- CMS approved 1<sup>st</sup> 5 year renewal
- Expanded to CCI counties
- Included Adult Residential Facilities as provider types
- Expanded per diem service rate to persons with TBI






## Assisted Living Waiver Enrollment December 31, 2010-2014











# Assisted Living Waiver Members by County December 31, 2014








# Assisted Living Waiver Participant Age December 31, 2014






#### Assisted Living Waiver Members Enrollment and Housing December 31, 2014


Member Residency at time of Waiver Enrollment






## NF/AH Waiver Enrollment December 31, 2010-2014








# Number of Individuals on NF/AH Waiver NF A/B Waitlist






## Average Days on NF/AH Waiver NF A/B Waitlist




## NF/AH Waiver Target Population by Full Scope Aid Code December 31, 2014






### NF/AH Waiver Benes by County December 31, 2014

## NF/AH Waiver Renewal and Transition Plan Public Comment Process



- ➤ DHCS will conduct a public comment period from May 1, 2016 through May 30, 2016 to allow stakeholders to comment on the NF/AH waiver and Transition Plan drafts.
- ➤ DHCS will collect and summarize stakeholders' input.
- ➤ Stakeholder input will be closely reviewed and considered for incorporation into the various components in the NF/AH Transition Plan.

Proposed Waiver Effective Date January, 2017





- Home and Community-Based Settings Final Rule
  - In 2009, the Center for Medicare & Medicaid Services (CMS) published an advance notice of proposed rulemaking that indicated the federal government's intention to initiate rulemaking on number of areas within the section 1915(c) program.
  - By March 16, 2019 every HCBS program must be in compliance with the final rule and have a CMS approved transition plan.





- Enhances the quality of HCBS and provides additional protections to individuals enrolled in HCBS programs.
- Maximizes opportunities for people to have access to the benefits of community living and receiving services in the most integrated setting.
- States must include a transition plan specific to the HCBS program to ensure compliance with the new Federal Rules.

# Overview of New Federal Provisions HCBS providers must meet the following qualifications:

- 1. Setting is integrated in and supports full access to the greater community;
- 2. Setting is selected by individuals from among setting options;
- 3. Setting ensures individual rights of privacy, dignity, respect, and freedom from coercion and restraint;
- 4. Setting optimizes autonomy and independence in making life choices;
- 5. Waiver participants have choice regarding services and who provides them;

## Overview of New Federal Provisions

Residential HCBS Providers - Congregate Living Health Facility (CLHF):

- 6. A lease or other legally enforceable agreement providing similar protections;
- 7. Privacy in unit including lockable doors, choice of roommates, and freedom to furnish or decorate the unit,
- His/her own schedule including access to food at any time;
- 9. Have visitors at any time; and
- 10. Lives in a setting that is physically accessible.

  - Participants
  - Providers
- ➤ On-site Assessments
- > Stakeholder Input
