**California's Foster Youth Struggle in Transition to Adulthood, Report Finds**

California Health Report - November 28, 2018

According to a new report by the Annie E. Casey Foundation, which draws together state and national data on foster youth transitioning to adulthood, California's transition age youth fare slightly better than the national average when it comes to finding a job and graduating from high school. But data shows that many foster youth aren't receiving the support they need to create stable lives once they leave foster care, and are less likely to receive a high school diploma or GED than their peers who haven't been in foster care.

**Why America needs an Interstate Child Abuse and Neglect Registry**

Child Welfare Monitor - November 28, 2018

The Adam Walsh Child Safety and Protection Act of 2006 required the Secretary of Health and Human Services to create a national registry of substantiated cases of child abuse and neglect. Yet this registry was never created. Health and Human Services later downplayed the potential benefits of such a database in a study it released and suggested the registry would only be useful as a time-saving tool.

**Foster Youth and Black Students are the Most Likely to be Suspended in School, New Data Show**

Just like the humans that designed them, algorithms and machine learning technologies carry biases wherever they go. Algorithm systems from Illinois to Los Angeles have been shut down due to unreliability or high rates of false positives, and even the system for the USDA food stamps program has shown evidence of racial bias. One solution to implicit bias is to have algorithms audited independently, a trend growing in the private sector.

Advocates see this as a red flag that will make it harder to understand how the juvenile justice system targets youth of color.

CCWIS is designed to give states the flexibility to design and implement a child welfare information system that meets their unique needs and give them an opportunity to rethink and redesign how they engage and serve families. case management system and launched support websites and webinars to help inform states and the public about the new system.
