**PUBLIC NOTICE AND REMOTE ACCESS TO COUNCIL AND COMMITTEE MEETINGS**

Public notice shall be given for the date, time, location and conference call number of all Council meetings and the meetings must be accessible to the public. **Child Welfare Council Committees and Workgroups**

Meetings and conference calls are convened by the respective chairs of these groups and do not need to be noticed publically if membership on the group is less than a quorum of the full Council.
