


NATIONAL PICTURE

Rate of children screened in for an investigation or assessment (per 1,000 children)




What might it mean for a community where 70 out of every 1,000 children experience a CPS investigation?



California Rate per 1,000 Children 0-17 in the Population






Baseline California Data Trends...

Entry Rate


Number of children entering foster care per 1,000 in the population

EQUITY


- Outcome: When your background and identity no longer determine your socioeconomic outcomes.
- Process: We apply equity when those most impacted by structural inequity are meaningfully involved in the creation and implementation of the institutional policies and practices that impact their lives.



Individual: Actions and beliefs

Institutional: Policies, practices and procedures

Structural: Historical and current institutional policies, practices and procedural that combine to create a system
